
UMI2628DB Leaf Spring Traction Bar Rocker – 3/4" raised

Installation

- 1. Lift rear of vehicle using your preferred method. Use a vehicle lift or jack and jack stands. Support the weight of the vehicle under the Chassis, allowing the rear suspension to fully "droop".
- 2. Remove wheels from vehicle to gain working access.
- 3. Support the axle with a jack or separate jack stands
- 4. Remove U bolts from Rear Axle.
 - *Cutting may be necessary if U bolts are rusted.
- 5. Remove Front leaf spring plate from chassis. There are (3) bolts per side to be removed.
- 6. The UMI front mount is a direct replacement of the factory front mount.
 - (2) mounting holes are provided to allow suspension tuning.

Bottom Hole – Factory location

Top Hole – Increases anti squat and lowers car 3/8" Commonly known as "Herb Adams Mod"



7. Install the mount onto the leaf spring bushing before installing in car. Use the supplied ½" bolt and Nylock to secure. Refer to picture below for Driver/Passenger side

Hardware Required:

- (2) 1/2-13 x 5" gr 8 Bolt
- (4) 1/2 Washer
- (2) 1/2-13 Nylock Nut

Torque: 55 ft lb

8. Install leaf into car, securing front mount with the hardware as describe below

Install Note

The front mount secures to the chassis with U clip nuts. If having difficulty lining up the bolt, remove the clip and ensure that it is not sprung open. If it is, gently squeeze together with pliers and reinstall clip

- 9. Finish install of leaf spring if disassembled. Confirm U bolt torque and rear shackle mounting.
- 10. Reinstall Wheels and lower vehicle onto ground
